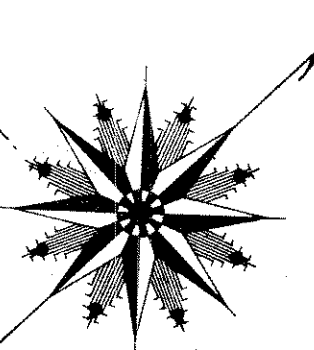


SUB PLAN
